

2. The selected officials will be on deputation for period of **one year** initially which can be curtailed or extended further, depending upon the requirement, and with the consent of the officials and approval of the lending department. The usual deputation terms will apply.
3. The application (in duplicate) filled as per proforma attached as Annexure-A along with the attested copies (on each page) of CR/APAR dossier for the last five years, Cadre Clearance, Integrity Certificate, Vigilance Clearance and details of Major/Minor Penalty imposed during last 10 years, in original duly signed and stamped by Competent Authority of the officials who could be spared in the event of selection, may be sent through proper channel to the Chief Controller of Explosives, 5th Floor, CGO Complex, Seminary Hills, Nagpur-440006 **within 45 days** from the date of publication of this circular in Employment News. Application received after due date or without the CR/APAR, Cadre Clearance, Integrity certificate or Major/Minor penalty statement or other wise found incomplete will not be considered.
