

SUBJECT: FILLING UP OF EIGHTY ONE (81) POSTS OF BARRACK & STORES OFFICER IN MILITARY ENGINEER SERVICES UNDER MINISTRY OF DEFENCE (MOD) ON DEPUTATION BASIS

Eighty One (81) posts of Barrack and Stores Officer (Group 'B') in the pay scale of Rs. 9300-34800 (PB-2) + Grade Pay Rs. 4600/- in Military Engineer Services (MES) are required to be filled on deputation basis. The eligibility conditions for applicants are as under:-

Officers under the Central/State Government:-

- (a) (i) Holding analogous posts on regular basis in the Parent Cadre/Department; OR,
- (ii) With five years service in the grade rendered after appointment thereto on a regular basis in the PB-2 of Rs. 9300-34800 with Grade Pay of Rs. 4200 in the Parent Cadre/Department; and
- (b) having the following educational qualification and experience:
- (i) Degree in Engineering in Civil/Mechanical/Electrical from a recognized University or passed section A & B of Associated Member of Institution Engineers Civil/Mechanical/Electrical Engineering.
- (ii) Two years experience in inventory control or Engineering stores management in any Government Organization/Department or in a Public Sector Undertaking or Private Limited Company/Recognized Institution.

Note 1:- The Departmental Officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.


Note 2:- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not to exceed three year. The maximum age limit for appointment by deputation shall be not exceeding fifty six years, as on the closing date of receipt of applications.

Note 3:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any upgradation.

2. The terms and conditions of deputation will be governed by the DOR&T's OM No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.
