(ii) Maximum 5% relaxation in aggregate in the degree certificate only for SC/ ST candidates, NCC 'C' certificate ('A' grade) holders, Sports person of National level(Inter State & above) and Wards of Coast Guard uniform personnel deceased while in service. No relaxation for 12th class marks.

(iii) While short listing applications for call-up, priority will be given to candidates with higher percentage of marks in the degree.

(iv) Candidates to choose any one branch and any one examination centre.

(v) Only candidates who have cleared their final year / final semester exams and completed their degrees are to apply.
