A candidate is not eligible to undergo apprenticeship training if the gap is more than three years. The candidate has to give a Declaration with application that he/she has not undergone apprenticeship training or job experience elsewhere after compliance of above mention branch/subject, under the Act.

Reservation: SC/ST/OC category benefit will be provided according to Apprentice (Amendment Act-1986).

Period of Training: One year.

Stipend: For Engg. Graduate Trainees -Rs 4983/-PM
 For Diploma Engineering Trainees -Rs. 3542/-PM
 For Technician (vocational) -Rs 2758 /-PM
 (No other allowance will be paid during the entire period of training)

Physical Fitness: Must be good mental & bodily health and must be free from any physical deformation.

Selection Process: (a) Selection will be made on the basis or percentage of marks obtained in the Degree/Diploma/Vocational Certificate of the respective trades.

No TA/DA shall be allowed to those who shall be provisionally selected and appeared in Pre-Medical examination.
