Applications are invited on the prescribed format as attached with this notice from eligible Indian citizens for 02 x Tradesman Mate (Mazdoor) and 01 x Tinsmith (**No of vacancies likely to change**) in Pay Scale of Rs 5200-20200 + Grade Pay Rs 1800/- plus allowances as admissible to Central government employees. The applications should reach 226 Coy ASC (Sup) Type 'G', Delhi Cantt-110010 within 21 days from the publication of this advertisement in Employment News.  - (iv) NO objection certificate duly authenticated by employer incase of Govt servants
 - (v) Discharge certificate for ex-servicemen where applicable
 - (vi) Meritorious sports persons should be in possession of certificate of the competition awarded by the following and a copy of the same should be attached with application :-

Candidates will enclose a self addressed envelope, affixing postal stamps of **Rs 25/-** required for registered cover for return of acknowledgement card so as to reach Commandant, 226 Coy ASC (Supply) Type G, Delhi Cantt-110010 by 1600 hrs **within 21 days from the date of publication of this advertisement in the Employment News/News Paper**. The covering letter/envelope should be marked with 'APPLICATION FOR THE POST OF _____'. No application will be entertained after closing date i.e. 21 days from the date of publication of this advertisement notice in Employment News/News Paper.

7. Acknowledgement card will only be sent to candidates whose application/supporting documents are found complete/correct in terms of age, mandatory educational qualification and other parameters as mentioned above. Physical test will be held at Delhi Cantt on the dates mentioned in acknowledgement card for each post. Candidates should report to designated location on date and time of test as mentioned in the acknowledgement card. No separate letter except acknowledgement card will be issued. No candidates will be allowed to attend the test if reports to venue after time specified. No intimation of rejection of applications will be given to the candidates.

8. The individuals should be in possession of acknowledgement card sent by this unit and all original documents for verification at the time of physical/written test. Individual who are not in possession of acknowledgement card will not be entertained.

9. All eligible candidates will go through the physical, written and trade test as prescribed appropriate to the duties/job requirement of the post (s) concerned.

10. The number of candidates may be reduced to a minimum of 50 times of the vacancies for one post by screening of applications on the basis of percentage of marks obtained in the examination for essential qualification will be carried out. A bench mark percentage will be fixed depending on the number of applications. No weightage will be given for additional/higher qualification (other than those prescribed in the Recruitment Rules). All candidates meeting the bench-mark will be allowed to appear in the physical/written examination. The administration reserves the right to fix a cut off/bench mark percentage on receipt of applications for which no one will have right to question/represent.

11. General Instructions.

(a) Please note that incomplete applications without affixing attested photographs duly attested by a Gazetted Officer or matriculation certificate showing date of birth duly attested by a Gazetted Officer or caste certificate (as applicable) or if applicant is found overage/underage on last date of receipt of application as indicated above will be rejected without intimation to the candidate. Only the eligible candidates will be called for tests.

(b) Candidate must ensure that no column is left blank or wrongly filled. Applications not filled correctly are liable to be rejected and onus of such rejection would be on the candidates himself. The application format should be typed on full scale paper (A-4 size) and forwarded to Commandant, 226 Coy ASC (Supply) Type G, Delhi Cantt-110010.

(c) No application will be accepted in person by hand or through any representative. The application must be posted to the addressee under registered/speed post cover. The unit will not be responsible for any kind of postal delay.

- (d) No TA/DA for the test will be paid. Candidates will make their own boarding/lodging arrangement for test.
- (e) Unit will not be responsible to pay any damages in case of injury/death of candidate whether direct or consequence suffered during physical/trade test. No claim in this regard will be entertained.
- (f) Merely fulfilling the basic selection criteria does not automatically entitle a person to be called for next test. Candidates would be considered for selection (including reserve) based on final merit list.
- (g) All posts are temporary but likely to be permanent with probation period of two years. 226 Coy ASC (Supply) Type G, Delhi Cantt-110010 reserves the right to withdraw the vacancies and terminate the appointment during the period of probation without assigning any reasons.
- (h) Selected candidates will be appointed on receipt of verification of their character and antecedents from civil authorities as well as that of the education, caste certificate from the concerned govt authorities and medical fitness.
- (j) Canvassing in any form shall disqualify the candidates. No enquiry or correspondence will be entertained in this regard. The decision of appointing authority will be final.
- (k) It may please be noted that if at any stage it is discovered that an attempt has been made by the candidate to willfully conceal or misrepresent the facts, his candidature may be summarily rejected or his employment terminated.
- (l) Candidates in relation with more than one spouse or have married another spouse while the first spouse is alive are not eligible for appointment to the said posts.
- (m) The recruitment process can be cancelled/suspended/terminated by the Commandant, 226 Coy ASC (Supply) Type 'G', Delhi Cantt at any stage and his decision in this regard is final and no appeal will be entertained.
- (n) The above mentioned posts/vacancies are tentative and only indicative. Unit administration reserves the right to increase/decrease the number of vacancies at any stage of recruitment.
- (o) Candidates not in receipt of acknowledgement card/call letter should presume that either their application could not come in shortlist or were found ineligible. NO correspondence in this regard will be entertained.

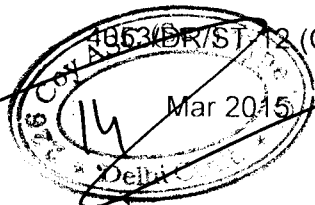
