Type of Commission.

SSC for Men & Women.

- (i) The engagement period for Flying Branch SSC officers is fourteen years from the date of Commissioning.
- (ii) The initial tenure for SSC officers in Ground Duty (Tech and Non-Tech) branches would be for a period of ten years. An extension of four years may be granted subject to service requirements, availability of vacancies, willingness, suitability and merit.
- Grant of Permanent Commission (PC) (at a later date) would be considered subject to service requirements, availability of vacancies, willingness, suitability and merit and as per prevailing policies on the subject
- SSC officers are not entitled for grant of pension.

- (a) Flying Branch. 20 to 24 years as on 01 January 2025 i.e. born between 02 January 2001 to 01 January 2005 (both dates inclusive). Upper age limit for candidates holding valid and current Commercial Pilot Li cense issued by DGCA (India) is relaxable upto 26 year i.e. born between 02 January 1999 to 01 January 2005 (both dates inclusive).
- (b) Ground Duty (Technical/ Non-Technical) Branches. 20 to 26 years as on 01 January 2025 i.e. born between 02 January 1999 to 01 January both dates Inclusive). 2005

7. Training. Training will commence in the first week of January 2025 for all courses at Air Force Academy Dundigal (Hyderabad). The duration of training for Flying and Ground Duty (Technical) Branches is 62 weeks and that of Ground Duty (Non-Technical) Branches is 52 weeks at Air Force Training Establishments. - Allowances. In addition to pay, allowances are applicable based on the nature of dutyl place of posting and it includes Flying, Transport, Technical, Field Area, Special Compensatory (Hill area), Special Force, Siachen, Island Special Duty, Test Pilot & Flight Test Engineer, Area and Remote Locality Allowance, etc.
- Privileges. Air Force Officers are entitled to furnished accommodation, comprehensive medical cover for self and dependents, Canteen, Officers' Mess, loans at subsidised rates, LTC etc. Leave (60 days annual and 20 days casual), subject to service exigencies.
- Insurance. Rs. 1.10 crore Insurance Cover (on contribution) is applicable to serving officers. An additional cover of Rs. 15 Lakhs (on contribution) is applicable to Flying Branch Officers.
- 12. <u>Sports and Adventure</u>. Indian Air Force provides state of the art facilities to play various sports and adventure activities (sky diving, micro light flying, mountaineering, water rafting etc.).

IMPORTANT INSTRUCTIONS

- Eligible candidates are to register online through separate tabs available for AFCAT Entry/ NCC Special Entry. Candidates eligible for one/more entries are to register separately in each entry.
- The policy on permanent body tattoos is as follows:-
 - Permanent body tattoos are not permitted on any other body part either (a) Permanent body tattoos are not permitted on any other body part either visible or non-visible part, except on the Inner face of forearms i.e. from Inside of the elbow to the wrist of both the hands and Reverse side of the palm / back (dorsal) side of both hands for which a candidate will be required to sign a Self-declaration Certificate. - 16. Conduct of Online Testing for AFCAT Examination and Fee Structure.

 Online testing will be conducted for AFCAT entry at various centers. Candidates registering for AFCAT entry will have to pay an amount of Rs. 550/- + GST (non-registering for AFCAT entry will have to pay an amount of Rs. 550/- + GST (non-registering for AFCAT entry will have a paydidates registering for NGC Secret refundable) as examination fee.  17. Marital Status. Candidates must be unmarried at the time of commencement of the course and marriage is not permitted during training. A candidate who marries during the period of training shall be discharged and will be liable to refund all expenditure incurred on him/ her by the Government.

- 20. Travel Allowance (TA).
